Verify Your Insurance Coverage

When you call to schedule your first appointment, a member of our staff will request your insurance policy information and call to verify your coverage for physical therapy. Your benefits will be provided to you in writing and explained in detail at your first physical therapy appointment.

Please note that the information we provide you is limited to that which your insurance company shares with us. If you have any questions or concerns regarding your physical therapy coverage, please contact your insurance company's member services line. Decide Whether to Use In or Out-of-Network Benefits

PhysioPartners offers both in and out of network providers and treatment options. You may choose to see a PhysioPartners Premier provider with limited insurance participation who will typically spend 45-60 minutes with you one-on-one every visit. In this case, insurance claim filing is offered, but your insurer will cover less of your care.

If seeing an in-network provider is important to you, schedule with one of our PhysioPartners fully participating providers who will always spend at least 30 minutes with you one-on-one every visit and work with our qualified team to help you make the most of your therapy time.

Either way, you can ensure that with one-on-one consultation and treatment included in every visit, your time is used more efficiently and focused on addressing the root cause of your problem.

Determine Patient Responsibility

Accepted forms of payment include personal check, all major credit cards and Care Credit. Care Credit can be used to pay out of pocket medical costs and finance expenses in excess of \$200 for up to 6 months. Apply for Care Credit by clicking below.



As a courtesy to you, PhysioPartners administrative staff will work to determine eligibility and coverage for therapy services by your insurance carrier. While every insurance policy is different, we anticipate the following ranges of coverage, depending on our participation with your network:

Coinurance Percentage	Estimated Patient Responsibility After Meeting Deductible for 30-45 Minute Sessions	Estimated Patient Responsibility After Meeting Deductible for 45-60 Minute Sessions
10%	\$10-\$15 per visit	\$15-\$20 per visit
20%	\$15-\$20 per visit	\$28-\$40 per visit
30%	\$20-\$32 per visit	\$40-\$60 per visit

If a deductible applies, the cost of the visit will be patient responsibility until the deductible is met. You can expect the cost of a 30-45 minute session to be between \$90-\$105 and a 45-60 minute session to be between \$140-\$175 depending on the procedures performed and the provider selected.

We also offer a day-of-service discount for 60, 45 and 30-minute appointment times, as well as additional discounts on pre-paid packages. These savings are available secondary to the reduced administrative burden created by filing insurance claims and collecting for services. Therefore, claims for these services cannot be submitted to an insurance company. **Since hourly rates vary, depending on your preferred physical**

therapist, please contact our office to inquire about your physical therapist's fees.

45-minute visit \$110 or \$130

30-minute visit \$75 or \$100

15-minute visit \$42.50
